TEXAS JUNIOR COLLEGE STUDENT GOVERNMENT ASSOCIATION: REGION II STANDING RULES

Rule 1. No delegate shall speak longer than three minutes, without permission of the convention granted by a two thirds vote without debate.

- (a) No more than two delegates for an issue. No more than two delegates against an issue.
 - (b) Will not exceed more than three minutes.

Rule 2. All reports and other material for the permanent record or printed proceeding committee discussions.

A. For each motion made by every committee in front of the General Assembly, discussion will be limited to two delegates "for" and two delegates "against." Each delegate who speaks will be limited to three minutes. Time will be kept by the parliamentarian.

B. The delegate who has presented the motion has the first opportunity at discussion.

Rule 3. The rules contained in the current edition of Robert's Rules of Order Newly Revised shall govern the convention in all cases to which they are applicable and in which they are not inconsistent with the bylaws of the society and these standing rules.

Workshop #3: Conflict Resolution Given By: Stephen Rogers


Building a team sometimes has its challenges. Come learn about conflict resolution and how conflict is an important part of any successful team or organization.

KEYNOTE SPEAKER: JOAN TRUMPAUER MULHOLLAND



Her Freedom Rider mugshot has been called one of the most iconic in American history. By the time she was 23 years old, Joan Trumpauer Mulholland participated in over 50 sit-ins and demonstrations including the Freedom Rides, the Jackson Woolworth's Sit-in, the March on Washington, the Meredith March and the Selma to Montgomery March. Her path has crossed with some of the biggest names in the Civil Rights Movement: Martin Luther King, Medgar Evers, Fannie Lou Hamer, John Lewis, Diane Nash and Julian Bond to name a few.

Joan is a recipient of the 2020 Simeon Booker Award for Courage, the 2019 International Civil Rights Museum Trailblazer Award, the 2015 National Civil Rights Museum Freedom Award, the Delta Sigma Theta Sorority, Incorporated Annual Award of Honor and the Anti-Defamation League Annual Heroes Against Hate Award.

She has appeared in several books including "Coming of Age in Mississippi", "Breach of Peace", "We Shall Not Be Moved", and, "She Stood For Freedom". She has appeared on television and news programs like the "CBS Nightly News" and award-winning documentaries including "An Ordinary Hero", PBS's "Freedom Riders", "Standing on My Sister's Shoulders" and the groundbreaking film "Eyes on the Prize".

Second a Motion	"Madame President. I (state
	name), (position) Second the motion"
Object to Personal affront or Procedure	"Point of Order" (Officers' Privilege]_
Complaint about noise, room temp. etc.	"Point of Privilege" (Officers' Privilege).
Request Info	"Request of Information"
Consider Something out of the scheduled order.	"I move we suspend the rules and Consider"
Postpone consideration of something.	"I move we postpone this matter until/After"
